The **Lewiston Comprehensive Plan Work Plan Development Committee** met in the Bell Building Second Floor Conference Room at 215 “D” Street. Chair Iacoboni called the meeting to order at 12:02 p.m.

I. CALL TO ORDER:

Chair Iacoboni called the meeting to order at 12:06.

II. APPROVAL OF 6/3/25 MEETING MINUTES

The 6/3/25 committee meeting minutes were approved by consensus.

III. REVIEW OF THE ENVISION LEWISTON 2044 ACTION PLAN FOR ITEMS TO ADD TO THE RELATED WORK PLAN

Planner Plaskon reported that City Engineer, Luke Antonich, had come to him to ask if he should bring the upcoming East Lewiston Transportation Network Analysis (the Analysis) project to the Planning & Zoning Commission for input. Plaskon advised Antonich to bring it, instead, to the Comprehensive Plan (the Plan) Work Plan Committee (the Committee) because it aligned with goals, objectives and actions in the Plan and would also bring additional support to the Analysis, & he had agreed, so was here to present that project so the Committee could decide whether or not to add it to the Work Plan.

Antonich provided the Committee with a map showing the two priority areas for the Analysis, as well as a written description of it and two pages of Plan goals, objectives, and actions he identified as being relevant to the Analysis. Plaskon asked the Committee if they desired to add the Analysis to the Work Plan. All Committee members present were in favor of doing so.

Plaskon reported that Public Works Director Johnson had also identified the upcoming Sidewalk Master Plan as being appropriate to consider adding to the Work Plan, and the Committee agreed, as it implements action item PSFU.1.2.1. The Committee then discussed whether or not to add anything else to the Work Plan, with focus on the Community Character Chapter of the Plan, but decided that it would be best to wait to do that until after the Lewiston Main Street Project was underway and until after the Chamber of Commerce got a new Executive Director and the Beautiful Downtown Lewiston Organization was again up and running.

IV. NEXT STEP(S)

Plaskon stated that he would schedule another Committee meeting to discuss the development of a new Parks and Open Space Master Plan with the new Parks Director, Justing Glenn and add the two initiatives described herein above to the Work Plan, as agreed upon by the Committee.

V. ADJOURNMENT

There being no further business, Chair Iacoboni adjourned the meeting at 12:30 p.m.
